
Enrolment Scheme Description

Effective from 06 Dec 2002

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below and as shown on the attached map will be entitled to enrol at Limehills Primary School.



It is important to note this is not specifically related to existing or proposed school bus runs, and the boundary includes both sides of any road or state highway.

Starting point rapid number 149 Riverside Road

- move North East to RN 328 Campbell Road
- East along Campbell Road crossing intersection State Highway 6 onto Lady Barkly Road
- Pass RN 119 to corner Devereux Road, turn North left onto Forester Road, to intersection Boggyburn Road and Limehills Browns Road
- Turn right East along Limehills Browns Road to corner Henderson Road RN 84.
- Turn left North along Henderson Road to intersection Shand Road, pass RN 169 to RN 560.

- North along Otapiri Gorge Road passing Cathcart Road to RN 297, travel overland to Otapiri Mandeville Road to RN 2369. Follow Otapiri Mandeville Road NW to intersection Otapiri Gorge Road RN 1103.
- Follow direct line to Benmore Otapiri Road RN 367 joining Dipton Winton Highway RN 1055.
- Cross South Hillend Dipton Road RN 715 to Days Road RN 47 to Harbour Endowment Road RN 486.
- Travel down Pike Road to RN268.
- Follow Crowe Road to join Looney Road RN 149.
- Overland to join Hundred Line East RN 867.
- Again overland to join Ryan Road RN 568.
- East along Ryan Road to intersection Ryan and Riverside Roads
- South down Riverside Road to RN 149.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Annually, the Limehills School Board of Trustees will determine the number of placements likely to be available to out of zone students seeking to enrol for the following year. This information will be published as a notice in a daily or community newspaper circulating in the broader area served by the school. Included in the notice will be details indicating how and by when applications from out of zone students are to be made.

Applications for enrolment will be processed accordingly in order of the following priorities:

- **First Priority** This priority is not applicable at this school because the school does not yet run a special programme approved by the Secretary for Education.
- Second Priority will be given to applicants who are siblings of current students.
- Third Priority will be given to applicants who are siblings of former students.
- Fourth Priority will be given to any applicant who is a child of a former student of the school.
- **Fifth Priority** will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- Sixth Priority will be given to all other applicants.

If there are more applicants in the second, third, fourth or fifth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary under Section 11G(1) on the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status will require to give proof of a sibling relationship.
